# NOTICE TO PURCHASER OF SPECIAL TAXING DISTRICT

The real property that you are about to purchase is located in the **Chateau Woods Municipal Utility District** (“District”) and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax as approved on September 16, 2025 is **\$0.2766** on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes approved by the voters, excluding refunding bonds that are separately approved by the voters, are:

**\$0.00** for water, sewer, and drainage facilities

**\$0.00** for park and recreational facilities

The aggregate initial principal amounts of all such bonds issued are **\$0.00**

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Oak Ridge North, Texas.
